TERMS AND CONDITIONS

1. Information on how to enter and the prizes forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promotional Period commences on **28 FEBRUARY 2020 at 9.00am (AEDST) and closes on Sunday 1 MARCH 2020 at 4.59pm (AEDST)**
3. Entry is open to residents of Australia only. (Eligibility for installation component of the SPL "Prize" is limited to Brisbane, Gold Coast and surrounding areas only). Employees (and their immediate families) of the Promoter(s) are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
