

**HOME SHOW GROWN x VEGEPOD PRIZE
BRISBANE AUTUMN HOME SHOW 2022**

TERMS AND CONDITIONS

1. Information on how to enter and the prizes forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promotional Period commences on **1st April at 9.00am (AEDT) and closes on Sunday 3rd April at 4.59pm (AEDT)**
3. Entry is open to residents of Australia only. Employees (and their immediate families) of the Promoter(s) are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Any entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter(s) to enter into a further agreement as evidence of consent to the minor entering this promotion.
5. To enter, individuals must complete the following steps during the Promotional Period:

 - c. Take their ticket to the Eco Town area, scan their ticket in with the provided scanner and partake in the Home Show Grown session with Wombat;
 - d. Take home an egg carton (supplied), seeds (supplied) and soil (supplied) and proceed to plant seeds at home;
 - e. Tag **@BrisbaneHomeShow @Vegepod @DiaryofaWombat** and **#HomeShowGrown** on Instagram and Facebook – minimum of three posts
 - f. Agree to be contacted via the contact details used when registering; and
 - g. Accept the competition Terms and Conditions.
6. The Prize is a Medium Raised Garden Bed with VegeCover 1m x 1m. Prize valued at \$299.00 including GST.
7. If the winner of the prize is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on the winner's behalf. A randomised draw via a computer program will take place at the **Exhibitions and Events Australia: Level 1, 801 Glenferrie Road Hawthorn, Victoria, 3122** before **FRIDAY 3 JUNE 2022 at 5pm (AEDT)**. The first valid entry draw will win the prize indicated in clause six (6) above. For the removal of doubt there will only be one (1) winner for each prize in this promotion. The draw conductor may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
